1. Introduction

The Gambling Regulatory Authority is inviting Expression of Interest (EOI) from prospective candidates (local and international) willing to work on a full-time/part time basis for the Horse Racing Division for the position of **Racing Executive Officer**.

2. Background

- 2.1 The Gambling Regulatory Authority is responsible for regulating all betting and gambling activities in Mauritius. Its role is to deliver prompt and effective service to its stakeholders, ensure that gambling activities are conducted in a fair and transparent manner, and foster responsible gambling in order to minimise harm caused by gambling.
- 2.2 The Horse Racing Division of the GRA is statutorily set up following the amendments brought to the Gambling Regulatory Authority Act 2007 through the Finance (Miscellaneous Provisions) Act 2021.
