1. I hereby authorise Horse Racing Division to check any details of information given in this statement, including but not limited to, criminal convictions, financial commitments, etc. as the Horse Racing Division in its absolute discretion deems necessary.
2. I acknowledge, if I am applying for a trainer’s licence that
  - (a) The training of all horses in my care will be under my personal supervision;
  - (b) I will notify HRD immediately whenever a horse leaves my control or comes under my control where it is my intention to prepare the horse to participate in trials or races; and
  - (c) I will permit the Stewards or Officials of HRD to enter at any time and inspect my property and to exercise their powers under the Rules.
3. If I am charged with an offence punishable by fine or imprisonment, I undertake to contact the Stewards immediately upon being charged.
4. If I have been convicted of an offence punishable by fine or imprisonment in the previous 12-months, I undertake to contact the HRD immediately and attach to this application a copy of my current Police Clearance Certificate and details of the Court ruling in relation to the offence.
5. I shall at all times conduct and present myself in a professional and proper manner and comply with the HRD Rules of Racing, Directions & Notices, Official’s instructions and the powers afforded to them and that failure to do so can place my current and future involvement in the industry in jeopardy.
6. I acknowledge having read and understood the said Rules and further undertake to read the Official HRD publications or monitor the HRD website so as to keep myself informed of any amendments to the said Rules or any other Regulations, Notices, Conditions and Directions made by HRD
7. I agree to be bound at all times by the said Rules in force from time to time and any other lawful Rules, Regulations, Notices, Conditions and Directions as may from time to time be formed, made or given by Stewards or Officials of HRD.
8. I acknowledge that in the event of becoming disqualified, I remain bound by and subject to the Rules of Racing for the period of my disqualification.
9. I further acknowledge that in the event of being disqualified, my licence is forfeited and upon expiration of the disqualification I must reapply for a licence. I recognize in these circumstances, such application may be refused or made subject to special conditions.
10. I will provide the Licensing & Registrations Department with written advice of any changes to the details I have advised in this application within 48-hours of the change.
11. I hereby declare that all particulars stated on this application are true and correct, that I have read all the conditions appearing in this Application and acknowledge and agree to abide by all such conditions.
12. I acknowledge that the Stewards are empowered to punish any person who makes any false or misleading statement or declaration in respect of any matter in connection with the administration or control of Thoroughbred Racing.

- 1) Curriculum Vitae, with two (2) Passport Size photographs;
- 2) Duly filled Personal Management License Form;
- 3) National identity card/ Valid Passport;
- 4) Birth Certificate;
- 5) Proof Of Address (Utility Bill or Bank Statement)- not older than 3 months;
- 6) Certificate of Character (issued not earlier than 3 months from date of application);
- 7) Clearance from Home Authority (Racing as well as Forfeit List Clearance), **if applicable**;
- 8) Racing Record, **if applicable**;
- 9) Proof of Financial stability,
- 10) Contract with the Owner,
- 11) List of horses (minimum 10);
- 12) Stable location;
- 13) Stable rent agreement.

**For a New Trainer's Licence, a person will have to undergo a written and Practical test, comprising of Rules of Racing and general stable Management.**
