- 6) Duly filled Personal Management License Form;
- 7) Medical History and Clearance Form;
- 8) Contract with the Stable;
- 9) Certificate of Character (issued not earlier than 3 months);
- 10) Racing Clearance from (Racing as well as Forfeit List Clearance);
- 11) Racing Record – Home Authority and Place where last rode;
