## **General**

1. Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses except for PROFICIENT (K. Ramsamy) whereby Assistant Trainer U. Nagadoo advised the Stipendiary Stewards that Jockey K. Ramsamy will not bounce the horse to lead and will be handy with pace and HIGH VOLTAGE (S. Rama) where Trainer A. Sewdyal advised that Jockey S. Rama will ride the horse with the intention to lead if it jumps well. These changes of tactic were disseminated to the public.

#### **Starting Reports**

- 1. GRAND FINALE (M. Sonaram) brushed the gates leaving the stalls.
- 2. HIGH VOLTAGE (S. Rama) and CHIEF RAFEEF (N Marday) were slow.

#### **Stewards Reports**

- 1. GRAND FINALE (M. Sonaram) overraced during most part of the running and jumped the crossings.
- 2. Jockey N. Marday (CHIEF RAFEEF) reported that his horse dropped the bit near the 600m.
- 3. LOVE ME AGAIN (R. Joorawon) was hanging in in the running and more so in the straight and in trying to correct his mount, Jockey R. Joorawon lost his balance in the concluding stages of the race. In view of the hanging in of LOVE ME AGAIN, Trainer C. Ramdin has been advised to take remedial measures with the horse.
- 4. GRAND FINALE (M. Sonaram) was hanging in, in the straight.
- 5. Jockey K. Ramsamy reported that PROFICIENT did not stride out freely in the running. In view of this report, the Veterinary Surgeon was requested to examine.

- 1. In view of the Starting Report, the starting stall certificate for PROTECTIVE LIGHT (K. Bhageeruthy) has been withdrawn. This gelding has been suspended by the Stewards for seven days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stewards.

1. Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses except for STAGEWORLD (K. Bhageeruthy) where Trainer D. Zaki advised that Jockey K. Bhageeruthy will not insist for the lead and MASTER OF ILLUSION (N. Marday) where Assistant Trainer U. Nagadoo advised the Stipendiary Stewards that the horse will be ridden from the rear. These changes of tactics were disseminated to the public.

## **Starting Reports**

1. TRANSONIC (B. Ecroignard) and CHOSEN WAY (R. Boutanive) brushed leaving the stalls.

#### **Stewards Reports**

- 1. The whip of Jockey R. Boutanive (CHOSEN WAY) was briefly entangled with his reins at the top of the straight.
- 2. CHOSEN WAY (R. Boutanive) shifted away from the whip in the straight.
- 3. Jockey R. Boutanive (CHOSEN WAY) appeared before the Board, was shown the patrol films of the race and advised against the practice of using his whip on consecutive strides in the running. Jockey R. Boutanive was issued with a warning.
- 4. Jockey J. Bardottier (TRIPPI'S EXPRESS) appeared before the Board in relation to his riding of TRIPPI'S EXPRESS from the 1000m to the 600m where it was observed that the



- gap had increased between him and the leaders. Jockey J. Bardottier explained that he was of the view that his mount could not move faster despite him trying. The Stipendiary Stewards noted the explanation of Jockey J Bardottier.
- 5. Relying on a report from the Veterinary Surgeon that TRIPPI'S EXPRESS was severely distressed after the race and posed a danger in races, TRIPPI'S EXPRESS has been accordingly, banned from racing. Trainer S. Hurchund appeared before the Stipendiary Stewards and was informed of the decision.

- 3. ACTION PACKED (K. Ramsamy) was wide in the early stages due to a wide draw and then from 600m to 300m and then began to give ground to the field.
- 4. SWAGGER JAGGER (B. Bhaugeerothee) was keen in the running in the early stages.
- 5. Jockey S. Rama (CLOUD SEEDER) appeared before the Board in relation to his riding in the early and middle stages of the race and he was queried whether he considered the option of letting his horse race more freely and try to take the lead considering that the pace was moderate. He explained that ONE DAY OR DAY ONE (J. Bardottier) jumped faster and travelled better than his mount and in those circumstances, he was happy where he was. The explanation was noted by the Stipendiary Stewards.

Jockey J. Bardottier has been asked to ride his horses in a manner that does not leave any room for query and a reprimand has been issued to him.

## **ADDITIONAL INFORMATION**

Trainer A Sewdyal was found in contravention of Rule 69.3, whilst his two horses – HIGH VOLTAGE & COLOUR MY FATE – were found to found have a mane shorter than required under the Rules of Racing. Subsequently, Trainer A Sewdyal signed an admission of guilt, and accordingly, a fine of Rs.5000 was imposed on him.
