General

1. Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses.

Starting Reports

- 1. SUPREME ELEVATION (J. Bardottier) was restless in its stalls.
- 2. SPECIAL DUTY (J. Allyhosain) hesitated and was slowly away, losing considerable ground.

Stewards Reports

- 1. In view of the Starting Report, the starting stall certificate for SPECIAL DUTY (J. Allyhosain) has been withdrawn. This gelding has been suspended by the Stewards for seven days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stewards.
- 2. LITTLE PAL (B. Soodoo), from a wide draw, travelled wide until the 900m.
- 3. CROONER (R. Joorawon) and TARTARUS (S. Rama) overraced in the early stages of the race
- 4. Apprentice B. Soodoo (LITTLE PAL) appeared before the Board in relation to his riding in the straight and subsequently, he was advised to maintain his balance and vigour while riding the finish.
- 5. Near the 1200m, TARTARUS (S Rama) was eased as CROONER (R Joorawon) shifted ground to take a position along the rails.
- 6. Jockey R. Joorawon (CROONER) was questioned regarding his ride in the early part of the race when he had an opportunity to try to lead after his mount had jumped well. He explained that his instructions were to race with cover and the horse had a soft mouth which he thought was a concern and thus he preferred to take cover behind the leader as per his instructions. Trainer C. Ramdin also appeared before the Board and he stated that (a) he was not sure of the running of the horse as it was only its second run in Mauritius, (b) he was also concerned with the soft mouth of the horse and expressed that he would attend to



it with immediate effect, and (c) after considering the Jockey's view, he stated that he would prefer the horse to run up in front and lead, if possible, in the future if the pace is average.

- 7. Jockey S. Rama (TARTARUS) reported that his horse was green in the running.
- 8. SUPREME ELEVATION (J Bardottier) had a tendency to hang in in the straight.

General

 Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses except for FASSI whereby Trainer D. Zaki advised the Stipendiary Stewards that the horse will be ridden with the intention to lead but will not insist if there is too much speed.

Starting Reports

1. CELESTIAL MAGMA (B. Ecroignard) jumped sideways and was slow.

Stewards Reports

1. Near the 1300m, CELESTIAL MAGMA (B. Ecroignard) brushed the rails and was awkward in its stride whereby the Apprentice lost his balance momentarily. Passing the 1300m, Apprentice Jockey B. Ecroignard (CELESTIAL MAGMA) adjusted his left stirrup. Further, BELIEVEINTHEFUTURE (N Marday) did not leave enough room on his inside



near the 1300m, which also had a bearing on this incident. Jockey N. Marday (BELIEVEINTHEFUTURE) was advised to leave more room on his inside when negotiating a turn.

- 2. App B Ecroignard and Trainer Mahadia appeared before the Board in relation to the start of CELESTIAL MAGMA and instructions being to lead or if someone else is faster, then to be 2nd.
- 3. At an Inquiry held at the Offices of the HRD on 29th May 2024, Apprentice Jockey B Ecroignard (CELESTIAL MAGMA) and Trainer S Mahadia were interviewed. Subsequently, Apprentice B Ecroignard was charged with a contravention of Rule 43.2.3, in that, whilst riding horse CELESTIAL MAGMA, he failed to take all reasonable measures to ensure that he rides to the instructions given to him.

Apprentice Jockey B Ecroignard pleaded guilty to the charge; and he was found guilty as charged.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for 04 Race Meetings.

Apprentice Jockey B Ecroignard has the right of appeal against the penalty imposed.

Trainer C. Ramdin has been advised to ensure that his horses are competitive at all times in a race.
