### **Starting Reports**

1. PROFICIENT (P. Mohun) jumped awkwardly and Apprentice P. Mohun brushed his left foot on the gates, injuring it.
2. RED ROCK CANYON (B. Soodoo) was slow to begin.
3. WAIMEA (R. Kulloo) began awkwardly.

### **Stewards Reports**

1. Near the 800m, FORT MCHENRY (N. Marday) was eased momentarily from the heels of PROFICIENT.
2. Near the 700m, RED ROCK CANYON (B. Soodoo) brushed the rail.
3. Apprentice R. Kulloo reported that WAIMEA dropped its bit near the 300m.
4. Apprentice R. Kulloo (WAIMEA) appeared before the Board in relation to his riding at the finish when he had weakened in his riding efforts. Considering the evidence in this matter, apprentice R. Kulloo has been issued with a severe reprimand and advised to ride his horses to the finish.
5. In view of the performance of WAIMEA (R. Kulloo), the Veterinary Surgeon was requested to examine.

2. After the start, CAPTAINS FORT (R. Oodith) was eased off the heels of BELLAGIO KING (K. Ramsamy), which shifted in.

**Stewards Reports**

1. LITTLE PAL (J. Bardottier) raced wide from the 1200m to 1000m.
2. Jockey J. Bardottier (LITTLE PAL) appeared before the Board in relation to his riding from the 1000m onwards. He advised the Board that his saddle had slipped sideways near the 1000m and thereafter he could not fully assist LITTLE PAL during the remainder part of the race. Jockey J. Bardottier was informed that he did not show the saddle slip to an official and further had failed to report to the Stipendiary Stewards all circumstances that may affect the running of his horse. Jockey J. Bardottier signed an admission of guilt in respect of a contravention of Rules 38.2.1 and 38.2.4 in relation to the above. Accordingly, a penalty of a fine of Rs 3,000 was imposed.
3. TARTARUS (S. Rama) was keen from the 1000m to the 850m.
4. Jockey N. Batchameah reported that CROONER hesitated at the 450m crossing.
5. In view of the performance of LITTLE PAL (J. Bardottier), the Veterinary Surgeon was requested to examine.

2. FRENCH REBEL (J. Bardottier) jumped awkwardly which resulted in Jockey J. Bardottier hitting his left knee onto the gate. He was subsequently referred to the Course Medical Officer and was subsequently stood down from riding for the remainder of the Race Meeting.
3. FRENCH REBEL (J. Bardottier) was slow into strides.

### **Stewards Reports**

1. Approaching the 1200m, FRENCH REBEL (J. Bardottier) was eased for a few strides as CAPKUTA (J. Allyhosain) shifted ground inward. Jockey J. Allyhosain has been cautioned.
2. Jockey N. Batchameah (LOVE ME AGAIN) reported that his horse was green in the running, jumped the crossing and was hanging in, in the straight. In view of the performance

of LOVE ME AGAIN and Jockey N. Batchameah's report, the Veterinary Surgeon was requested to examine.

- Jockey K. Ramsamy reported that DAYLA VISTA was not striding out in the running. In view of the performance of DAYLA VISTA and Jockey K. Ramsamy's report, the Veterinary Surgeon was requested to examine.

### **General**

- On a request from Trainer A. Sewdyal, MASTER KEEKU was permitted to leave the paddock with earplugs and same were removed at the start.

### **Starting Reports**

1. FIBBER MAGEE played up in the stalls and injured Jockey N. Marday in the process. The handler was also injured and consequently the horses were offloaded which caused a delay in the start of the race. FIBBER MAGEE was withdrawn and suspended from racing for 7 days and until completing a barrier trial to the satisfaction of the Stipendiary Stewards.
2. CARLAS MAMBO (N. Batchameah) was stubborn to load and consequently withdrawn. CARLAS MAMBO has been suspended from racing for 7 days and until completing a barrier trial to the satisfaction of the Stipendiary Stewards.
3. VARTACUS (B. Ecoignard) jumped awkwardly and threw its head.
4. MASTER KEEKU (S. Rama) and WAR MEDAL (S. Bhundoo) were slow.

### **Stewards Reports**

1. Near the 800m, VARTACUS (B. Ecoignard) was keen, shifted out, causing MASTER KEEKU (S. Rama) to shift further out.
2. Near the 500m, WAR MEDAL (S. Bhundoo) travelled wide, causing EL PATRON (K. Ramsamy) to travel wider.
3. Jockey S. Rama (MASTER KEEKU) signed an admission of guilt in respect of a contravention of Rule 43.2.4 in that he made an excessive celebratory gesture prior to the finish of the race. Accordingly, a penalty of a fine of Rs 5,000 was imposed.

1. After the start, STAGEWORLD (J. Allyhosain) commenced to shift in and passing the 1300m, shifted in further and took the running of JUNIPER LANE (R. Boutanive). An inquiry had been opened into this incident.
2. Jockey R. Boutanive (JUNIPER LANE) appeared before the Board in relation to him not being able to follow the instructions which was to lead. Jockey R. Boutanive advised that after a comparatively slow start, STAGEWORLD (J. Allyhosain) paced much better than his horse and then cut across him, causing him to hold back JUNIPER LANE. Thereafter, he tried to bring his horse behind STAGEWORLD. Jockey R. Boutanive's statement was countered when it was put to him that he had ample opportunity when his horse was racing between STAGEWORLD and THE CONTRACTOR (K. Ramsamy) to let his horse stride out freely and try to lead as instructed and it appeared that his horse's mouth was open which signified that he was holding him back. Trainer S. Mahadia appeared before the Board and advised that in his opinion, the race was lost at the start as STAGEWORLD was faster than his horse. Subsequently, he agreed that the Jockey R. Boutanive has taken the next best option of electing to sit behind STAGEWORLD and in the running of the race, it appeared to him that JUNIPER LANE could not have paced with STAGEWORLD. However, a review will be held into the riding of Jockey R. Boutanive in this race.
