General

- 1. Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses except for ENIGMA CODE (J. Bardottier) where Trainer D. Zaki advised the Stipendiary Stewards that Jockey J. Bardottier will not insist for the lead and CHRISTMAS ICECREAM (G. Aucharuz) where Trainer N. Rawat advised the Stipendiary Stewards that the horse will be ridden with the intention to lead. These changes of tactics were disseminated to the public.
- 2. Prior to the start of this race, the near fore shoe of FRENCH REBEL (J. Allyhosain) had to be refitted.
- 3. After being loaded, CHRISTMAS ICECREAM (G. Aucharuz) played up in the stalls, injured the Jockey and ducked under the gates and bolted. Subsequently the horse was scratched. As the horse was apprehended, it collided with the rails near the 270m. Accordingly, the gates and rails had to be fixed.
- 4. Jockey G. Aucharuz was referred to the Course Medical Officer and was subsequently stood down for the remainder of the race meeting.
- 5. In view of the above factors, the start of the race was delayed.

Starting Reports

1. FRENCH REBEL (J. Allyhosain) was slowly away by two lengths.

Stewards Reports

1. In view of the general report, the starting stall certificate of CHRISTMAS ICECREAM was withdrawn and the horse has been suspended from racing until proving tractable in the gates.

Racecard Changes

- 1. Jockey K. Ramsamy was replaced by Jockey J. Bardottier on ENIGMA CODE.
- 2. Jockey J. Bardottier (ENIGMA CODE) carried 1kg over the carded weight and weighed out at 61kg.

1. CHRISTMAS ICECREAM (G. Aucharuz) was scratched at 12h21. All monies invested on CHRISTMAS ICECREAM was ordered to be refunded. Fixed odds winning bets were deducted by 50 cents per rupee on the face value of the ticket.

- 3. Jockey J Allyhosain (OCTOBER SUN) wore the Emergency Colours i.e. All Black, due to the non-availability of registered Racing Colours.

Starting Reports

1. After leaving the stalls, NINOTTO (J. Bardottier), from a wide draw, shifted in sharply and carried VARTACUS (B. Sooful) inwards with it.

Stewards Reports

- 1. VARTACUS (B Sooful) over raced and had to be restrained on several occasions.
- 2. An inquiry has been opened into why VARTACUS (B. Sooful) was carried in and shortly after had to ease.
- 3. Trainer D. Zaki signed an admission of guilt for a contravention of Rule 47.9.2 in that as the Trainer of the horse OCTOBER SUN, he failed to ensure that the horse carries the correct equipment as required by the Rules of Racing. Accordingly, a penalty of a fine of Rs 5,000 was imposed.

Starting Reports

- 1. CHIEF RAFEEF (J. Bardottier) was slow by three lengths.
- 2. HIGH VOLTAGE (S. Rama) was slow, losing considerable ground.

Stewards Reports

- 1. In view of the Starting Report, the starting stall certificate for HIGH VOLTAGE (S. Rama) has been withdrawn. This gelding has been suspended by the Stipendiary Stewards for seven days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stipendiary Stewards.
- 2. RED ROCK CANYON (B Soodoo) was keen in the running in the early stages of the race.
- 3. App Jockey B Soodoo (RED ROCK CANYON) struggled to free his whip from the reins in the straight.
- 4. Jockey M Sonaram (AFRICAN ROCK) was questioned in relation to his ride after the start and then between the 500m to the 300m. He stated that, as per his instructions, he was asked not to bounce his mount at the start as the horse is a hard puller. When asked why he stayed one off while he could go on the fence and follow POWER TOWER, he said he feared his mount would start to pull once the pace is slowed down uphill which is usually the case. He further advised that he was asked to ride his horse from 300 metres and not before. Whilst noting his explanation, Jockey M Sonaram was severely reprimanded and been advised that he should ride his horses so as not to leave any room for query in the future.

- 1. Trainer A. Rahmathulla was found in contravention of Rule 69.3, whilst his two horses, MARAUDING and TICKET TO CAIRO, were found to have a mane shorter than required under the Rules of Racing. Subsequently, Trainer A. Rahmathulla signed an admission of guilt, and accordingly, a fine of Rs.5,000 was imposed on him.
- 2. Trainer D. Zaki was found in contravention of the Declaration Guidelines in that he failed to obtain the consent of Jockey K. Ramsamy (ENIGMA CODE) prior to declaring him. Accordingly, a penalty of a fine of Rs 3,000 was imposed on him.
