1. UNIVERSE BOSS (K. Ramsamy) was slow.
2. MIDNIGHT ORACLE (A. Roy) was slow.

**Stewards Reports**

1. Leaving the stalls, HIGH VOLTAGE (S. Rama) was eased.
2. Near the 1750m, HIGH VOLTAGE (S. Rama) was eased as LITTLE PAL (N. Batchameah) shifted out.
3. Near the 1700m, HIGH VOLTAGE (S. Rama) was again eased as PERFECT PURSUIT (R. Oodith) shifted in.
4. UNIVERSE BOSS (K. Ramsamy) was wide near the 1600m turn.
5. TIMEINTHEWOODS (R. Joorawon) had a tendency to lay in, in the running and near the 400m more so and was eased as CLOUDED HILL (B. Sooful) passed him on the outside.
6. Jockey N. Batchameah (LITTLE PAL) appeared before the Board in relation to his celebratory gesture on the winner and accordingly he has been issued with a reprimand.
7. Trainer Y. Perdrau appeared before the Board and was queried about the improved performance of LITTLE PAL (N. Batchameah). In this regard, he advised that the horse was improving in work outs with blinkers since late but he did not expect him to win. He added that as LITTLE PAL is a one pacer, he tried it over 1850m and he thought he would run a place at best. The Board noted the explanation of Trainer Y. Perdrau.

### Starting Reports

1. DON'T LINNGAR (K. Ramsamy) was awkward leaving the stalls and brushed with BENEV (A. Roy) and INAUGURATION (B. Sooful).

### Stewards Reports

1. FUTURE APPROACH (R. Oodith) hung in, in the straight and the horse was unbalanced at the 100m under the continual used of the whip. Jockey R. Oodith was issued with a reprimand.
2. Jockey N. Batchameah (NEVIL MU) appeared before the Board in relation to the performance of his horse. In this regard, he advised that the horse jumped well but he found him not interested in the race and he did not travel well throughout the race despite his urgings. He added that probably the kickback also did not help the horse. In view of the

poor performance of NEVIL MU, the horse was referred to the Veterinary Surgeon and select to provide a sample.

1. It started raining before the start of this race.
2. Prior to the running of this race, Trainer D. Zaki advised the Board that his instructions to Jockey R. Oodith were to ride CLEAN SLATE in a forward position and that MASTERFUL GUY (A. Roy) will be dropped fourth or fifth at the start. The change of tactic was disseminated to the public.

### **Starting Reports**

1. MASTERFUL GUY (A. Roy) jumped awkwardly.
2. GIGGIN (B. Bhaugeerothee), after jumping out, shifted in and was slow into strides, losing ground.

3. AENEAS (S. Rama) was slow.

### **Stewards Reports**

1. Near 1200m, AENEAS (S. Rama) was eased briefly.
2. Near the 1000m, Jockey B Sooful (MANHATTEN CAFE), who was leading, took a hold of his horse in anticipation of any movement from it due to the presence of a person holding an umbrella which caused GIGGIN (B. Bhaugeerothee), FOREIGN FIELD (R. Joorawon), AENEAS (S. Rama) and CLEAN SLATE (R. Oodith) to be eased in varying degrees. The Clerk of the Course, J. Sampson, was accordingly advised.
3. Jockey R. Oodith (CLEAN SLATE) reported that his horse had a tendency to lay in, in the running and his horse dropped the bit near the 600m.
4. Approaching the 100m, CLEAN SLATE (R. Oodith) was switched out to make its run due to lack of room in front of him due to FOREIGN FIELD (R. Joorawon) shifting in and GIGGIN (B. Bhaugeerothee) shifting out marginally at that stage.
5. Jockey R. Oodith (CLEAN SLATE) appeared before the Board, was shown the patrol films of the race and advised against the practice of using his whip more than 7 times before the 150m. Jockey R. Oodith was issued with a warning.

2. Near the 1000m, COLOUR MY FATE (S. Rama) shifted in and crossed over in front of EMBLEM OF HOPE (R. Oodith) which was checked. Accordingly, Jockey S. Rama appeared before the Board and was shown the patrol films of the race in this regard. Jockey S. Rama signed an admission of guilt for a contravention of Rule 43.2.2 in that as the rider of the horse COLOUR MY FATE, he failed to ensure that he did not cause interference to EMBLEM OF HOPE (R. Oodith). A suspension from riding in races for a period of one race meeting was imposed.
3. Leaving the 1300m, EMBLEM OF HOPE (R. Oodith) shifted in and tightened COLOUR MY FATE (S. Rama). Jockey R. Oodith appeared before the Board and was shown the patrol films of the race in this regard. Jockey R. Oodith signed an admission of guilt for a contravention of Rule 43.2.2 in that as the rider of the horse EMBLEM OF HOPE, he failed to ensure that he did not cause interference to COLOUR MY FATE (S. Rama). A suspension from riding in races for a period of one race meeting was imposed effective 18<sup>th</sup> August 2024.

3. Jockey B. Sooful (LUNAFACATION) reported that his horse did not stride out in the running and accordingly LUNAFACATION was referred to the Veterinary Surgeon.
4. Jockey R. Oodith (ARNHEM LAND) appeared before the Board, was shown the patrol films of the race and advised against the practice of using his whip on consecutive strides in the running. Jockey R. Oodith was issued with a warning.
5. Jockey R. Oodith (ARNHEM LAND) signed an admission of guilt for a contravention of Rule 29.2.13 in that he struck the horse ARNHEM LAND with the whip more than 7 times before the 150m. Accordingly, a penalty of a fine of Rs 2,000 was imposed.
6. Jockey S. Rama (ABSOLUTIST) signed an admission of guilt for a contravention of Rule 29.2.13 in that he struck the horse ABSOLUTIST with the whip more than 7 times before the 150m. Accordingly, a penalty of a fine of Rs 2,000 was imposed.

### **ADDITIONAL INFORMATION**

#### **Race Meeting 12; Race 01 – run on 20<sup>th</sup> July 2024.**

An Inquiry held at the Offices of the HRD on 07th August 2024, Jockey J Allyhosain (PROFICIENT) was interviewed with regard to his riding and was assisted by Trainer SP Nagadoo. After having heard the evidence in the matter, the Stipendiary Stewards decided not to pursue with the matter any further.

#### **Race Meeting 13; Race 07 – run on 27<sup>th</sup> July 2024.**

An Inquiry held at the Offices of the HRD on 07th August 2024, Jockey J Allyhosain (CAPTAIN SEAGER) was interviewed with regard to his riding in the final straight causing interference to ONE DAY OR DAY ONE and QUATRO FIVE SIX. Subsequently, Jockey J Allyhosain was charged with a contravention of Rule 43.2.2, in that, he failed to ensure that he did not cause interference to another horse.

Jockey J Allyhosain pleaded guilty to the charge.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for a period covering 02 Race Meetings.

Jockey J Allyhosain has the right of appeal against the penalty imposed.

#### **Race Meeting 13; Race 08 – run on 27<sup>th</sup> July 2024.**

Jockey J Allyhosain (SPOTTED PEARL) was found guilty of contravention of Rule 43.2.4 and subsequently signed an admission of guilt, in that, whilst riding his horse, SPOTTED PEARL, he failed to ensure that he did not make an excessive celebratory gesture before the finish.

Accordingly, a penalty of a fine of Rs.5000 was imposed.
