1. Whilst proceeding to the start, Jockey G. Aucharuz was dislodged from EAGLES VISION, which was loose on the track. The horse was apprehended and was subsequently withdrawn, causing a delay in the start of the race.

1. PETECA (M. Sonaram) jumped awkwardly and brushed with ALPENHORN (R. Joorawon).

Stewards Reports

1. Jockey M. Sonaram (PETECA) reported that his horse had a tendency to hang out during the running.
2. PETECA (M. Sonaram) weakened near the 500m and was not competitive thereafter.
3. ALPENHORN (R. Joorawon) had a tendency to lay in, in the straight.
4. Jockey R. Boutanive (BELIEVEINTHEFUTURE) lost his whip near the 200m. Accordingly, Jockey R. Boutanive was issued with a reprimand.

1. The shoe of POWER TOWER (G. Aucharuz) was attended to prior to the horses arriving in the paddock.

Starting Reports

1. UNIVERSE BOSS (B. Bhaugeerothee) was slow.

Stewards Reports

1. An objection was lodged by Jockey C. Segeon, rider of the provisional second placed horse (THE HITMAN) against Apprentice A. Mosaheb, rider of the provisional winner (WHIPPING BOY), alleging interference as from the first time 300m (1600m) to the 1200m. Jockey C. Segeon explained that he received pressure from WHIPPING BOY, causing him to check at the 1200m which was his main objection. In this regard, the patrol films of the race were viewed from the different angles and Jockey C. Segeon, Trainer V. Ruhee, Apprentice A. Mosaheb and Trainer S. P. Mootien were interviewed by the Stipendiary Stewards. In arriving at this decision, the Objection Board considered the distance between WHIPPING BOY and THE HITMAN at the finish (0.55 lengths), the proximity of the incident to the finish and the extent of the alleged interference. From a viewing of the patrol films, it was established that the interference at the 1100m, rather than, 1200m was marginal, for a very brief period and no major prejudice was caused to THE HITMAN as there was fair distance available in the race for THE HITMAN to cover ground on WHIPPING BOY. The Stipendiary Stewards could not be satisfied that but for the above incident, THE HITMAN would have finished ahead of WHIPPING BOY. The Objection Board overruled the objection and allowed the judge's result to stand.
2. Leaving the stalls, CAROLINA REAPER (M. Sonaram) shifted out causing RAVISHING RAMBO (K. Ramsamy) to shift out further, inconveniencing UNIVERSE BOSS (B. Bhaugeerothee).
3. CAROLINA REAPER (M. Sonaram) was keen in the running in the early stages of the race.

- Following the incident at the 1100m, Apprentice A. Mosaheb (WHIPPING BOY) has been advised to be more careful while shifting ground in races.

Stewards Reports

- AL JAZEERA (R. Joorawon) was eased briefly near the 1000m.
- Jockey B. Sooful (WILLIAM BLAKE) reported that his horse dropped its bit near the 600m.

3. AL JAZEERA (R. Joorawon) shifted in, in the concluding stages of the race and went across STEPPING OUT (M. Sonaram) and then FRENCH REBEL (J. Allyhosain), causing the latter a brief ease. Accordingly, Jockey R. Joorawon has been issued with a caution.
4. STEPPING OUT (M. Sonaram) shifted away from the whip in the final 150m and then had a tendency to hang out.
5. In view of the performance of WILLIAM BLAKE (B. Sooful), the Veterinary Surgeon was requested to examine.

ADDITIONAL INFORMATION

1. Prior to the commencement of the race meeting, Trainer N. Rawat appeared before the Board and advised that there was no electricity in his stable for a few hours, therefore, there is no camera recording of his stables. Further, he advised that the main gate of the secure stables was open when he came to the stable for work and there were tyre marks of a vehicle in the passage of the stables where his horse TROJAN QUEST (J. Allyhosain), a declared runner in race 4, was stabled. He advised the Board that, in those circumstances, he was not comfortable to race his horse today and requested for its withdrawal. The Security-In-Charge, Mr. B. Souci and Mr M. Ramkissoon were questioned in this regard. Subsequently, the Stipendiary Stewards permitted TROJAN QUEST to be scratched. The Veterinary Surgeon was requested to sample the horse, however, due to a miscommunication, the horse could not be sampled.
2. On a request from The Turf News representative, Jockey C Segeon was permitted to sport a go-pro camera on his helmet whilst riding THE HITMAN in Race 2 on a test basis.

3. 24 August 2024 - Race 6 - 15:25 - The People's Turf Plc Stayers Trophy

At an inquiry held at the HRD office, Jockey R. Boutanive (LUNAFACATION) was interviewed in relation to his riding. He explained that he was instructed to lead or race in a forward position in case another runner jumped better. He said he elected to sit second one off early as the field was going uphill from the 1800m and tried to come next to the leading horse leaving the 1500m when the pace slowed down but the latter had a tendency to leave the fence on a few occasions. He further added that his mount moved up quite well leaving the 700m but then failed to keep pace prior to entering the final straight and was disappointing.

Trainer S. Mahadia when queried, stated that he would have preferred to see his horse in the lead but after listening to the explanation of his Jockey and in view of the circumstances of the race, he could not blame Jockey R. Boutanive even if he is of the view that he could have moved up before the 600m. Nevertheless, he was left disappointed by the performance of LUNAFACATION. The Stipendiary Stewards did not proceed further in the matter but warned Jockey R. Boutanive that his ride was of some concerns and he was reminded of his obligation to ride his horses so as not to leave room for query in his future rides.



4. Meeting 18 – Race 6 – The Peopleturfclub.com Cup

A review into the riding of Apprentice R. Kulloo (COLOUR MY FATE) was held. After consideration and having heard the explanation of apprentice Kulloo, Stewards did not proceed further into the matter.

5. Meeting 18 – Race 8 – The Gulu Armoogum Association Bonne-Mere Flacq Cup

A review was held into the running of this race. After having considered the instructions taken by Stipendiary Stewards on race day and the running of the race, no further action was taken into the matter.
