- 6. Jockey S. Donohoe (NEVIL MU) reported that his saddle slipped in the running which was confirmed by an Official.

  - a. The saddle of CAROLINA REAPER (C. Bennett) was refitted behind the gates.
  - b. HIDDEN KING (R. Campos) reared up in its stall, flipped over and was subsequently withdrawn on Veterinary advice.
  - c. AFTER THE ORDER (J. Allyhosain) was taken out from its stall and reloaded.
